BY THE HEARING EXAMINER: On May 27, 2025, the Commission issued an Order Establishing General Rate Case, Scheduling Hearings, Establishing Procedural and Filing Requirements, and Requiring Public Notice (Scheduling Order). It has come to the Hearing Examiner's attention that the Public Notice attached as Appendix A to the Scheduling Order contained an error regarding the date of the expert witness hearing.

NOTICE IS HEREBY GIVEN that on August 13, 2025, Cape Lookout Cabins & Camps, Inc., a North Carolina corporation (d/b/a Cape Lookout Cabins & Camps Ferry Service and d/b/a Morris Marina Ferry Service) (CALO), filed an Application for Rate Increase (Application) pursuant to N.C. Gen. Stat. §§ 62-32 and 62-134 and Commission Rules R1-4, R1-5, and R1-17. In its Application, CALO seeks Commission approval to increase its rates and charges for leisure ferry services listed on the Schedule of Rates attached to this Notice to Customers and to subsequently allow annual rate adjustments based upon the federal Cost-of-Living Adjustment (COLA).

The Application, as well as prefiled testimony and exhibits of the parties, hearing transcripts, post-hearing briefs and proposed orders, may be viewed as they become available on the Commission's website at www.ncuc.gov, by clicking on "Docket Search" and typing in Docket No. "A-66 Sub 4."

Persons having an interest and desire to intervene in the matter as formal parties of record may file their petitions to intervene no later than June 10, 2026, and in accordance with Commission Rules R1-5, and R1-19.

Notice is given that a hearing for the purpose of receiving public witness testimony on the Application is scheduled to begin at 11:00 a.m. on June 24, 2026, in Carteret County Courthouse, 300 Courthouse Square, Beaufort, North Carolina. The public witness hearing will be conducted solely for the purpose of receiving the testimony of public witnesses in accordance with Commission Rule R1-21(g). The Commission reserves the right to limit testimony at the public witness hearing pursuant to Commission Rule R1-21(g)(5).

This hearing is subject to cancellation if no significant protests are received by the Commission by 5:00 p.m. on June 17, 2026.

The hearing on the Application will resume in Beaufort, North Carolina, on June 24, 2026 immediately following the public witness hearing, or beginning at 11:00 a.m. if the public witness hearing is cancelled, and will continue as necessary until conclusion, for the purpose of receiving expert witness testimony of CALO, the Public Staff, and other intervenors. The hearing will be held in Carteret County Courthouse, 300 Courthouse Square, Beaufort, North Carolina.

The Public Staff is authorized by statute to represent consumers in proceedings before the Commission. Written statements to the Public Staff should include any information that the writers wish to be considered by the Public Staff in its investigation of the matter. Such statements should be addressed to Mr. Christopher J. Ayers, Executive Director, Public Staff – NCUC, 4326 Mail Service Center, Raleigh, North Carolina 27699-4300.

However, such written statements cannot be considered competent evidence unless those persons appear at the public witness hearing and testify concerning the information contained in their written statements. Persons may also email the Commission a statement about the application via the Commission's website at www.ncuc.gov/contactus.html. In either case, consumer statements will be placed in Docket No. A-66, Sub 4, and may be accessed by searching for that docket number via the Commission's website.
